

GENERAL INFORMATION

REGISTRATION

Mail-in registration must be post-marked by Wednesday, June 3rd. After that day, registration must be done in person at the Kendall Park Learning Center. Registrations accepted after June 27th will require a \$25 late fee.

REFUNDS OR CANCELLATION

- The tuition, minus \$250, is refundable if a student withdraws on or before May 30th.
- If student withdraws on or before June 14th, 50% of tuition will be refunded.
- If student withdraws after June 13th, 0% of tuition will be refunded.
- If the course is cancelled, the course tuition will be refunded in full.
- Refunds take approximately six weeks to process.
- There will be no refunds for missed days or holidays.
- There will be no refunds for workshops.
- *Students, who withdraw from the courses early, either because the class is too easy or too difficult will not have their tuition refunded. Students whose behavior is unsuitable for a classroom environment (either distracting or detrimental to the class and fellow students) will be asked to leave without any refund of tuition.*
